

In March 2024, International Flavors and Fragrances (“IFF”) announced the sale of its Pharma Solutions business unit to Roquette Frères S.A. (“Roquette”), a *société anonyme* organized under the laws of France. Pharma Solutions business will remain a part of IFF until the transaction closes.

In anticipation of the transaction close in second quarter 2025, IFF will change selected legal entity details and billing instructions on February 1, 2025.
